 - John Nanney reported that he and Rick Halle had met with the Clark County Sheriff Community Outrach Commander Phil Sample about the ride. Turns out the Phil is not only a Veteran himself but also a motorcycle rider. He was very enthusiastic about our plans and felt strongly in supporting it. He said he needs to get approval from command, next week but felt that it would go well and he should have news back next week. In the meantime we discussed costs associated with their assistance. It turns out that this could cost as much as \$700. However, he will work with reserve officers to see if he cannot find some volunteers. If he can, normally that will be for free. He seemed to feel that the chances of getting reserve officers was pretty good. As he said, the more money he can save us, the more gets into our veterans program! What a patriot!

Rick discussed the website saying that it is really close. He has been working with the database portion. In the meantime members can go look at it at <u>http://wrfv.org/</u> we should be ready for testing soon.

John noted that he would be in contact with Ilani and that with luck we should be going public with advertising within the next two weeks. In the meantime he asked the membership to please advertise our GoFundMe page on Facebook, Twiter, friends Family, we need money to run this. We currently have raise a total of \$640 on the website, but we really need more.

We need to get patches ordered and John recommends at this point we consider using the money earned so far to go towards that end. He will work on costs. Bottom line, we need all members to advertise our page.
